## RESEARCH TIP 7 | Use Forecite® as a Backstop

Forecite, helps you by identifying seminal cases that can easily be missed by ordinary word searches.

### Example

Search for: **busing AND desegregation**

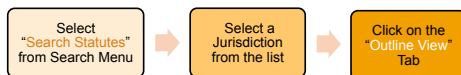
