



Introducing: Mobile Sync

Log in to Fastcase from your bar association, law school or law firm landing page. Once logged in, scroll over the **Options** menu and select **Mobile Sync**.

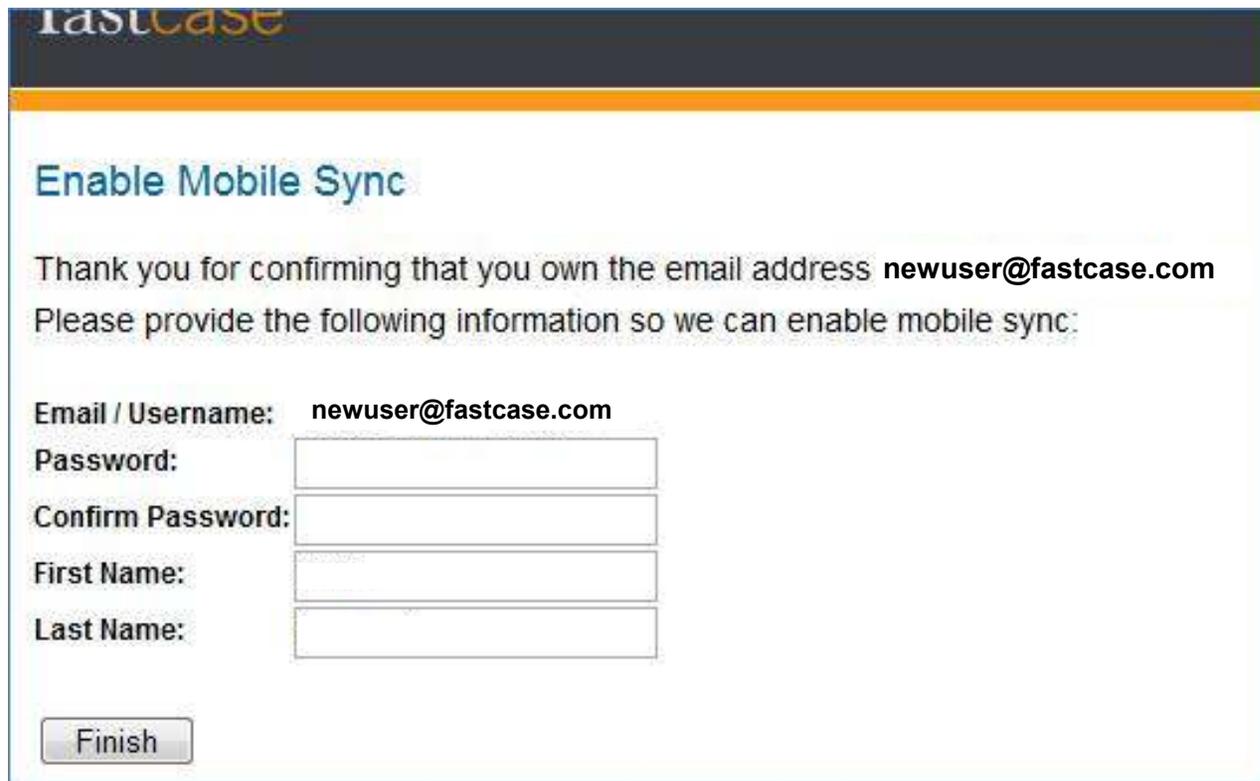
*If you already use the app and are simply syncing your two accounts, please use the email address associated with your preexisting app account.
